**Meeting was conducted publicly at Borough Hall; and remotely by zoom.

President Sanguedolce called the meeting to order at 6:30pm.

 - *Report on Executive Session(s)-An Executive session was held prior to this meeting to discuss Fire Department.
 - Open Paving Bids for Melvina/Piatt Streets. Six bids for this paving project were received. A motion was made by Ruth Little to accept the bid of Big Rock Paving of \$48,468.25; second by Margaret Mathis. Motion carried.
